**THE MOTOMARATHON ASSOCIATION, LLC RELEASE AND WAIVER OF LIABILITY,  
ASSUMPTION OF RISK, AND INDEMNITY AGREEMENT**

IN CONSIDERATION of the ability to participate in Motomarathon Association, LLC events, I agree that:

1. I understand that Motomarathons are organized motorcycle rides on public roads. A Motomarathon is not a race, and all events can be completed well within traffic laws and without breaking the rules of the road. I understand the nature of the events and my own experience and capabilities to participate in the events, and must be responsible for my own vehicle license, registration and insurance coverage. By participating in Motomarathon Association, LLC's events I certify that I am cognizant of all of the inherent dangers of motor vehicle operations, understand safety practices and traffic rules and regulations, and understand that I should not participate in any events if there are any conditions that may impair my ability to participate without creating risk to others or myself.
2. I fully understand that activities of the events are very dangerous and participating involves risk and dangers of serious bodily injury, including permanent disability, paralysis, death and property damage. These risks and dangers may be caused by my own actions, inactions, or negligence; the actions, inactions or negligence of others, and could result in severe consequences.
3. I hereby accept and assume all risks, both known and unknown, and assume all responsibility for the losses, costs and/or damages following any such injury, property damage, disability, paralysis or death, if caused, in whole or in part, by my own or others' negligence, including negligent rescue operations.
4. I hereby release, discharge and covenant not to sue the Motomarathon Association, LLC, its owners, its officials, sponsors, promoters, participants, associates, partners, vendors, suppliers or any subdivision thereof, or premises used to conduct the events, in any way associated with the organization and its events, from all liability to me, my personal representatives, assigns, heirs and next of kin for any and all claims, demands, losses or damages on account of any injury to me, including but not limited to death or damage to property, caused or alleged to be caused in whole or in part by my own negligence or negligence of other parties. This release is intended to be as broad and inclusive as is permitted by the laws of the Provinces or States in which the events are conducted and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.
5. If, despite this release, I or anyone on my behalf makes a claim against the Motomarathon Association, LLC its associates or participants, I agree to hold harmless these entities from any litigation expenses, attorneys' fees, loss, liability, damage, or cost they may incur due to the claims made, whether the claim is based on negligence or otherwise.
6. I state that I am of lawful age and legally competent to sign this affirmation and release, and that I understand the terms herein are contractual. I have signed this document as my own free act and if I have any doubts concerning the contents of this release agreement, I will consult an attorney before signing it. This agreement shall be governed by and construed under the laws of the State of Colorado.

I have read this release, fully understand its terms, and understand that by signing it I give up substantial rights I would otherwise have to recover damages or losses from parties involved and associated with the Motomarathon Association, LLC, its owners and participants. I have signed voluntarily with no inducement, assurance or guarantee being made to me and intend my signature to be a complete and unconditional release of all liability to the greatest extent allowed by law.
